Dues and fees are reevaluated annually as part of the planning and budgeting process. The fees shown here cover the 2018-2019 membership year only. Membership Dues

The 2018-2019 fiscal year starts June 1, 2018 and ends on May 31, 2019. Members joining between June 1st and January 1st are responsible for a full year’s dues. Members joining after January 1st pay one half of the fiscal year’s dues. 2018-2019 fiscal year dues categories are:

- Family Membership (2 adults regardless of religious affiliation with or without children) **\$2,800**
includes two High Holy Day tickets plus High Holy Day tickets for your children under age 30
- **PLEASE NOTE: First time members with children enrolled in religious school receive a 50% reduction in dues for their first year of membership**
- Single Membership (1 adult with or without children) **\$1,545**
Includes one High Holy Day ticket plus High Holy Day tickets for your children under age 30
- Senior Fixed Income Membership (2 adults 65 or over who are on a **fixed income**) **\$1,170**
Includes two High Holy Day tickets
- Senior Fixed Income Single Membership (1 adult 65 or over who is on a **fixed income**) **\$669.50**
Includes one High Holy Day ticket plus High Holy Day for your children under the age of 30.

Building Fund

All new members pay \$2,250 towards Ner Tamid’s building fund. This may be paid over six (6) years at a minimum of \$375 per year. If you can provide records of comparable contributions to another synagogue’s building fund (such as a letter to us from that synagogue), all or part of this responsibility can be waived.

Security Fee

All members are required to pay an annual security fee of \$75

Religious School Tuition

New members who wish to enroll children in the Ner Tamid religious school should also submit religious school registrations, and should make an appointment to talk to our Education Director, Iris Schwartz, who can be reached at the temple office. For the 2018-2019 school year tuition per student is as follows:

Payment Schedule

You incur a full year’s financial obligation at the beginning of each fiscal year; we would greatly appreciate payment of dues, building fund and tuition at that time. Dues each year may be paid over the course of the year (without interest) as long as you pay a minimum of 33% by 9/1/18, 66% by 11/1/18, and 100% by 2/1/19. B’nai Mitzvah fee payable before the bar/bat mitzvah. **New members must submit at least the minimum payment amount due at the time of their application.**
